### **NOTICE OF PUBLIC RULE-MAKING HEARING NEBRASKA REAL PROPERTY APPRAISER BOARD**

Notice is hereby given that the Nebraska Real Property Appraiser Board will hold a rule-making hearing on Monday, June 23<sup>rd</sup>, 2008, at 9:30 a.m. in the Nebraska Real Property Appraiser Board Office, Lower Level, Nebraska State Office Building, 301 Centennial Mall South, Lincoln, Nebraska.

The hearing will be held on the question of adopting amendments to sections of Admin. Code Title 298 of the Nebraska Real Property Appraiser Board Rules and Regulations. The proposed changes will incorporate the changes implemented with the *2008 AQB Criteria*; reference to adopt the *2008-09 Uniform Standards of Professional Practice*; removing obsolete references to the criteria prior to 2008; changing the language in reference to each credential for consistency; changes which relate to the new federal requirements to education and experience requirements for licensure and certification; continuing education; core curriculum education; collection of fees for demonstration report review; changes to enforcement and disciplinary procedures; and changes to comply with federal guidelines. No fiscal impact is anticipated for any state agency, political subdivision or regulated person.

All interested persons are invited to attend and testify at the hearing. Written comments may also be submitted prior to the hearing and will be made part of the record at the time of the hearing provided the comments are received by Thursday, June 12, 2008.
